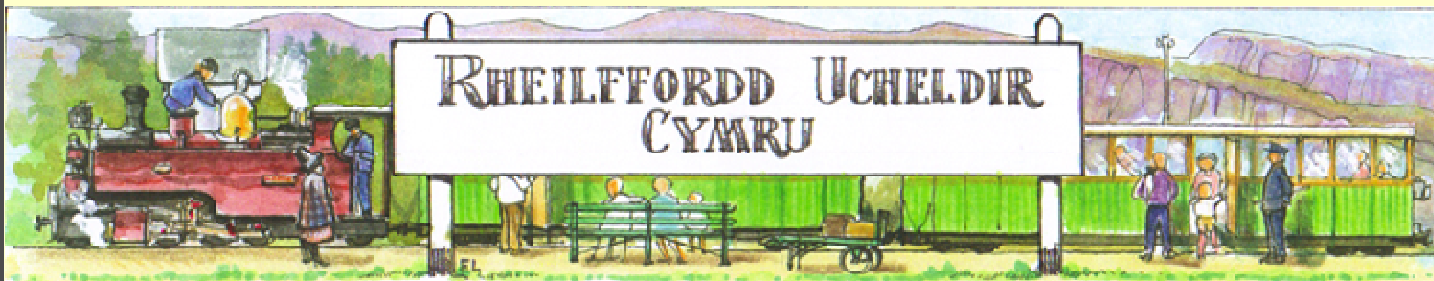
The railway is operated by the Welsh Highland Railway Ltd., a democratic member owned charity.
